**Police files case against Shirish Parkar of MNS**

**Mumbai, Saturday :** Election Commission has taken serious cognizance of derogatory comments of Shri Shirish Parkar MNS Spokesperson regarding BJP leader Shri Ram Naik. A police case has been filed against him.

Shri Shirish Parkar, spokesman of MNS and candidate for Vileparle Assembly Constituency shocked everyone when he said,"Ram Naik needs blood transfusion every three months. Ram Naik hates Marathi " from a platform of IBN Lokmat - Marathi Channel. BJP activists and Shri Ram Naik's followers were hurt by these totally false remarks made in bad taste. However, Shri Ram Naik restrained himself and brought the matter to the notice of the Election Commission.

The election code of conduct forbids candidates from making personal defamatory and/ or false allegations. Yet Shri Parkar made these statements. It is pertinent to note that Shri Parkar made such an indecent statement when Shri Ram Naik had not undergone blood-transfusion even once in his life. Shri Ram Naik has dedicated his life for people irrespective of their religion, language,caste,etc. Yet Shri Parkar dared to say that 'Ram Naik hates Marathi' Shri Ram Naik filed his complaint of breech of election code against Shri Parkar on 2nd October and also submitted footage CD to the Election Commission.

Taking serious cognizance of the complaint Shri Tanaji Shinde, Returning Officer of Vile Parle directed Vile Parle Police Station to take legal action. Accordingly, police have registered an offence against Shri Shirish Parkar under section 188 of C.P.C.

"We expect atleast basic decency even from a political opponent. I wonder why MNS spokesman targetted me in such a bad taste. That too when I am not in election fray. I am confident that voters would teach a fitting lesson to MNS by defeating their candidates", stated Shri Ram Naik at the end.
